### **Early Warning System Project Analysis**

The overall risk rating for AF2 is Substantial.

Environmental and Social risk is Substantial. While Environmental risk is Moderate, the Social risk is Substantial due to the vulnerability of FHWs to poor employment practices, GBV/SEAH, as well as overall project-wide low trust in GM. The risk is to be mitigated through training on labor management practices, recruitment of a Senior Social Specialist with GBV related skills; management of GBV and SEAH risks in recruitment/retention of female workers; development of an SEAH prevention and response action plan; and strengthening of the GM with appropriate structures, procedures and channels to enable safe, confidential and ethical reporting of GBV/SEAH and other incidents.
