Key environmental risks include: a) Occupational Health and Safety (OHS) risks for project workers resulting mainly from fragility, rehabilitation of project-supported healthcare facilities, exposure to hazardous chemicals, and prevalence of security incidences; and b) risks of infection and potential gaps in the proper handling and management of medical wastes, resulting from the improper disposal or use of sterilization unit waste, disinfectants, antiseptics, reagents as well as biological and infectious waste (bandages, needle tips, specimen containers, blood bags) and radioactive waste.
