According to the Bank's website, the objective of this project is to support the development of an adaptive and crisis-resilient social protection system that will contribute to any future crisis resilience among poor and vulnerable households.

The overall risk rating for the proposed AF is Moderate, same as assessed under the parent Program. The new activities identified under the AF do not pose any additional risks.
