#### **Project Description**

According to the Bank's website, the objective of this project is to protect poor and vulnerable households' consumption in response to shocks in Zambia.

On February 29, 2024, the Government of Republic of Zambia declared a national disaster and emergency in response to the severe drought caused by El Niño weather conditions and exacerbated by climate change. The current extremely dry conditions have precipitated the driest season in the last 40 years in many countries in Southern Africa. In Zambia, it has been estimated that food security of some six million people in 84 of the 116 districts is being impacted by the on-going drought. In an urgent effort to avert a humanitarian crisis, the Government of Republic of Zambia is allocating resources for emergency relief, with a particular focus on scaling up of social assistance programs and food distribution, among other initiatives.
