Environmental risk rating The Project's environmental risks have been analyzed and is "Moderate". In summary, the project will have considerable positive outcomes, as it aims to strengthen the preparedness, response, and resilience of health systems in Burundi to HEs. The main environment, health, and safety risks include infectious waste; pharmaceutical waste; chemical waste; contaminated wastewater; lack of provision of adequate potable water at healthcare facilities; potential existing on-site environmental liabilities; potential environmental, health, and safety impact/risks; air emission sources at healthcare facilities; and potential risks related to exposure of biological agents; and health safety risks and impacts that may result from exposure to hazardous materials/waste, and radiation. No greenfield civil works are expected during the project implementation.
