The basic health care provision program (BHCPP's) essential benefit package prioritizes cost-effective services, focusing on reproductive health, maternal care and nutrition, childhood illnesses, and non-communicable disease (NCD) screening. The HOPE-PHC Program is built around three key results areas: (1) improving quality of services; (2) improving utilization of essential services; and (3) improving the resilience of the health system.
