## Project Description

According to the Bank's website, the objective of this project is to create an ecosystem for successful commercialization of medical technologies among the Indian Council of Medical Research (ICMR) institutions.



### Early Warning System Project Analysis

Environmental Risk Rating: Moderate. The key factors contributing to the Moderate risk rating are: (i) good institutional capacity in storage and research on biological material and properties, (ii) extensive experience of managing biomedical wastes at the research institution level, (iii) good capacity of managing occupational health risks through use of personal protective equipment at the research facilities.

Social Risk Rating: Low. The grant's focus is on research and commercialization of research by granting access to biological materials and properties for innovation and product development. This is unlikely to have any adverse impacts on social issues of inclusion and equity. The developed products will be available for use by the general public, including as and when required by vulnerable sections of the society through the government medical health support system.
