## Project Description

Founded by the Eudists in 1990, Corporación Universitaria Minuto de Dios (“Uniminuto” or the “company” - <https://www.uniminuto.edu/>), is the largest private and non-profit university institution by enrolment. Uniminuto has a main campus in Bogotá (San Juan Eudes) and currently operating 65 municipalities of 21 departments distributed in 12 locations in Colombia as of October 2021. It offers undergraduate, postgraduate, and continuing education, targeting the low-income population. It has about 91,542 under-graduate and graduated students and approximately 4,065 faculties. The proposed IFC investment is a \$25 million long-term debt facility to finance the execution of 2020-2025 development plan. The facility will specifically finance the company’s 2021-2022 plan: (i) expansion and modernization of two campuses – Bogotá Calle 90 and Neiva and (ii) expansion of technology and virtual educational programs (“the Project”). IFC invested to the company in 2009 to support the expansion of three campus (Bogotá main campus, Soacha, and Girardot) and exited in 2017.
