According to ADB documents, the project will support the development and operation of a submarine fiber optic communication cable system linking Samoa to Fiji where an existing international submarine cable network will provide onward cost-effective access to the rest of the world. The proposed project will also support reforms to strengthen the regulatory and legal environment for the information and communication technology (ICT) sector, and facilitate investments in e- health solutions.

The impact of the project is universal access to reliable and affordable ICT services. The outcome of the project is quality broadband services available at an affordable price and used for enhancing e-health.
