The Project is expected to have a highly developmental impact through the investment in a local potato chip and snack manufacturer in Tajikistan. The Project will support the local agricultural supply chain by distributing seeds and sourcing potatoes from roughly 600 farmers in Tajikistan. The Project will help Tajikistan achieve UN Sustainable Development Goals #8 (Decent Work and Economic Growth) and #12 (Responsible Consumption and Production).
