### Project Description

According to the submitted proposal to the Green Climate Fund, this project seeks to strengthen institutional capacities and increase the resilience of at least 5% of the population in the pilot countries using an Enhanced Direct Access (EDA) system. It will specifically address prevalent barriers to climate change adaptation; the barriers are: 1. adaptation that leaves no one behind, 2. financing for adaptation in public, private, and civil society sectors, and 3. high per capita losses and costs of climate recovery.

The outputs of the project are:

1. Enhanced capacity for climate adaptation planning, implementation, and monitoring and evaluation via direct access.
2. Governments implement concrete adaptation measures using ecosystem-based approaches where appropriate.
3. Community resilience to climate change impacts is enhanced through tangible adaptation benefits.
4. Privately owned physical assets of vulnerable populations are more resilient to climate variability and change through concessional microfinancing.

## Investment Description

Government co-financing: US\$6.0 million
