## Project Description

This project finances the purchase and refurbishment of locomotives to contribute to enhancing the efficiency of freight services on the Serbian railway network. As part of a related project, the EBRD is also funding a track renewal program.

## Investment Description

- European Bank for Reconstruction and Development (EBRD)

This project is a reallocation of an existing sovereign guaranteed loan to JSC Serbian Railways. This reallocation works to aid in the unbundling of the vertically integrated JSC Serbian Railways.

The loan is restructured to fund Serbian Railways JSC and Serbia Cargo JSC. These have also previously benefited from several technical cooperation grants.

The Client for this project is Serbia Cargo JSC, a state-owned railway freight operator established in August 2015 as a result of unbundling of the vertically-integrated JSC Serbian Railways.
