The Natural Capital Lab is a joint venture of the IDB's Climate Change and Sustainability Division with the IDB Lab. This TC will support CSD in the development of the Natural Capital Lab. It will enable the Lab to generate knowledge and capacity to support the deployment of Natural Capital Lab resources committed by the governments of France and the UK. Specifically, it will support identification and development of innovative tools and financing models to value and protect the region's natural capital, and systematize and transmit those products to the region's countries through workshops, and in projects developed by the Natural Capital Lab with IDB Group departments.
