## Project Description

According to the bank website, the project consists of the construction of a new 3 km road section between the N21 (on the right bank of the Garonne River) and the D119, directly connected to the new motorway interchange on the A62 (Agen Ouest), which is part of the Atlantic Core Network Corridor. The road is a single carriageway (1 1 lanes) with a separated bi-directional path for cyclists and pedestrians. It includes a bridge over the Garonne River, and a viaduct crossing the side channel to the Garonne River. The project also includes the re-meandering and revegetation of existing artificial ditches within the road corridor.

### ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
