### Project Description

The Project involves existing plantation forestry operations and the production of wood chips for the biomass energy sector or conversion to pulp for other wood-based products. The Project grows *Acacia mangium* and *Eucalyptus pellita* as the principal species and is undertaking provenance trials of *Eucalyptus urograndis* X *urophylla* as part of its genetic improvement program. Currently, 38,000 hectares are in production. The Project's long-range forest plan seeks to have a total of 150,000 hectares in production by 2029 and to reach a sustainable harvest of over 5 million tons/year.
