### Project Description

According to the Bank's website, the project consists of a senior loan of up to KZT 4.1 billion (EUR 8.5 million) to PPP Centre of East Kazakhstan Region JSC to complete the modernisation of the street lighting system in the city of Ust-Kamenogorsk via the construction of additional 6,000 spotlights along ca. 150 municipal streets in the City and its vicinity. The project will enable the City to cover its public area with a modern energy efficient street lighting system including suburban areas, where street lighting had not been introduced before. The project is expected to save around 60 per cent of primary energy and CO2 emissions compared with the baseline.

The Project is consistent with the Municipal and Environmental Infrastructure Sector Strategy (BDS19-069(F)), which calls for "increased access to essential municipal infrastructure focused on quality, resource efficiency, reduced environmental impact".
