Project Description

According to bank documents, this project provides financing to Goyol Cashmere LLC to construct and operate a factory and apartment building for production of knit-wear clothing.

Goyol Cashmere procures raw cashmere directly from herders living in rural areas of Mongolia, and works with local businesses to process, dye and spin it before producing finished cashmere products for sale. Goyol Cashmere provides technical assistance to herders from which it procures raw cashmere to improve the quality of the cashmere.
