The Sustainable Agriculture Transformation Project for Vietnam aims to improve farming productiveness and value chains, and strengthen relevant public agencies to productively support the implementation of the agricultural restructuring plan.

The project includes four components.

The first component: Strengthening national institutions to support agricultural transformation.

The second component: Supporting sustainable rice-based systems for around 30 key rice producing districts in eight Mekong Delta provinces in a cluster approach.

The third component: Promoting sustainable coffee production by supporting the transformation of Vietnam's coffee sector to sustainable practices.

The fourth component: Project management, monitoring and evaluation will sustain the project's achievements.
