## Project Description

According to EIB website, the project will finance a new hot stove for the existing integrated steel plant's blast furnace A, as well as the integration of a heating station in the steel shop. The project comprises the capital expenditures related to the installation of new key equipment. This will lead to a significant increase in energy efficiency, entail a considerable reduction of CO2 emissions and increase the consumption of secondary instead of primary raw material. Both investments will lead to more efficient iron and steelmaking and will help to strengthen the promoter's competitiveness.

The Bank's services will establish during the due diligence of the project whether a new EIA is required, as well as appraise any other environmental details.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
