## Project Description

According to EIB website, the project will design (partly), construct(partly), finance, operate and maintain the 76.3km A3 motorway section between the Biebelried intersection (AK Biebelried) and the Furth/Erlangen intersection (AK Furth/Erlangen) in the German State of Bavaria. The project is to be procured through an availability-based public-private partnership (PPP) model for a period of 30 years including construction. In particular, the project refers to the widening to six lanes (2x3) of a 76.3km section of the A3 motorway. It aims to improve traffic conditions by increasing capacity on a congested section of the German and European road network. The project will improve connectivity in Bavaria and is part of a larger programme to improve German motorways.

The project is acceptable for the Bank from an environmental and social point of view with conditionalities as presented in the Environmental and Social Data Sheet.

Total amount of loan is not disclosed for this project.

### ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
