Project Description

The Hospital Especialidades Umiña, Hospiumiña S.A. “Hospital Umiña” (“Hospital de Manta” or “the Project”), covers the construction and operation of a hospital facility that includes 47 hospital rooms, 2 delivery rooms, 8 ICU (intensive care unit) beds, 5 neonatal bassinets, 4 operating rooms, 10 post-surgery recovery beds, 10 emergency unit stretchers (2 pediatric). The gross construction area of the project is 11,259 m² and it will be located in the province of Manabí, Manta district, in a residential area (Barrio Umiña). The Project will be implemented in lots C and D , with an area of 5,357 m² and 5,122 m², respectively, owned by HOSPIUMIÑA Compañía Anónima . Construction will take place in approximately 12 months.
