## Project Description

According to EIB website, The project will involve financing urban/architectural reconstruction of private residential buildings/houses, as well as economic infrastructure (owned by small and medium-sized enterprises (SMEs)), damaged by extreme weather conditions (e.g. strong winds, storms and unexpected heavy rains) in the last four years in sixteen regions of Italy. It aims to bring wider economic benefits through the restoration of suitable livelihood and business conditions affected by the numerous extreme weather events in Italy.

Subject to the conditionalities described in the bank documents, the Project is acceptable in environmental and social terms.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
