## Project Description

The proposed IFC investment consists of creating a Distressed Asset Recovery Program (DARP) platform in Mexico to acquire and resolve secured and unsecured retail non-performing loan portfolios and Real Estate Owned by financial institutions. IFC will be partnering with Zéndere Group, a relevant distressed asset (DA) player in Mexico, which will service the NPL portfolios and also invest alongside IFC and other co-investor(s) in the Project.

IFC investments entails a Senior Profit Participating Loan of up to US\$30 million (equivalent in MXN) to a newly created special purpose vehicle to be established by Zéndere and other co-investor(s).
