## Project Description

According to the Bank's website, the project concerns the promoter's development of a hands-free walk exoskeleton used for medical rehabilitation and to improve wheelchair patients' mobility.

The promoter is already commercialising Atalante, an exoskeleton for stroke patient rehabilitation. Atalante enables these patients to re-learn how to walk by recovering their gait, more effectively than both manual rehabilitation techniques and 1st generation exoskeletons. In addition, Wandercraft is developing Eve, a personal exoskeleton for wheelchair users. By improving their daily life mobility, the Company's objective is to decrease wheelchair-related pathologies and negative impacts, such as unemployment or depression.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
