## **Project Description**

The general objective of this programme is to promote energy efficiency in government facilities and fuel conservation in road transportation by contributing to the avoidance of fuel imports. The specific objectives and expected results of this programme are: (i) reduced electricity consumption within health, education and public agency government facilities, which translates into lower Carbon Dioxide (CO<sub>2</sub>) emissions; (ii) reduced travel times and avoided fuel consumption through improved traffic control management, which translates to lower CO<sub>2</sub> emissions; and (iii) increased capacity within the Ministry of Science, Energy and Technology (MSET) to enable it to update its Integrated Resource Plan (IRP) for Jamaica.
