According to the CDB, the project will improve the efficiency, safety and climate resilience of the road network in Antigua. The project entails the preparation of final designs, rehabilitation and upgrade of four corridors on the island of Antigua. Anchorage Road 1.44 km, Sir Sidney Walling Highway 14 km, Old Parham Road 2.9 km and Valley Road 9.45 km, a total of 27.8 km.
