According to ADB website, the ADB is working with the People's Republic of China to design an efficient urban transport system to capitalize on new high speed rail links planned for Ji'an in Jiangxi Province. The project is developing an urban road network with bike lanes and other non-motorized transport options, as well as a bus rapid transit system served by 15 stations and a fleet of 95 buses.
