Project Description

According to ADB website, ADB is helping the People's Republic of China construct a 50-megawatt concentrating solar thermal power (CSP) plant in Qinghai province. It will be the first utility-scale CSP plant in the country. The project will also include capacity development and training in CSP construction, operation, and management. The power plant is expected to generate 199 gigawatt-hours of electricity annually.
