Project Description

The program objective is to improve efficiency and equity in the delivery of public services, in order to enhance economic competitiveness and social inclusion. This general objective will be achieved through the following specific objectives: (i) modernize access to a set of strategic transactions for businesses and citizens; (ii) enable access to public services for citizens with the greatest social needs; (iii) strengthen the AIG and other government entities with responsibilities in e-government and process streamlining; and (iv) improve the capacity of the Ministry of the Environment to process transactions.



Investment Description

- Inter-American Development Bank (IADB)

The program will have a total cost of US\$30 million, to be financed with proceeds from an investment loan for US\$22 million from the Bank's Ordinary Capital and a local contribution in cash of US\$8 million. The disbursement period will be five years.
