## Project Description

The preparatory activities for the project is to build a multipurpose deepwater port in the Northwest region of the country. This project aims to improve the competitiveness of Guinea's mining products, in particular bauxite, and is also of vital importance for the development of West Africa due to the reinforcement of intra-community trade which will be induced.

The project feasibility study is conducted to:

- (i) formally identify the optimal site for the development of a deepwater port in the North-West region of Guinea;
- (ii) determine the technical and economic feasibility, financial and socio-environmental of the construction of the said port;
- (iii) design and size the future port platform at APS level;
- (iv) formulate recommendations with regard to managing the environmental and social impact of the planned developments.
