Project Description

The objective of this operation and the programmatic series is to make social protection spending for the poor more transparent, equitable, and efficient and to enhance its ability to foster human capital accumulation. This operation is the second in a series of three programmatic policy-based loans (see Related Projects).



Investment Description

This operation is structured as a programmatic policy-based loan. The choice of this instrument is justified for the implementation of medium-term reforms, in a context of increasing delivery capacity (stimulated by the operations within the series as well as parallel investment operations), utilizing in each phase the knowledge acquired previously. The amount of financing for this second operation in the programmatic series will be US\$200 million, drawn from the IADB's Ordinary Capital resources.
