## Project Description

The objective of this second operation is to help reduce morbidity and mortality caused by chronic noncommunicable diseases in Argentina, prioritising the population with public coverage only. Specifically, this operation proposes to help: (i) prioritise the primary care level as the gateway to the health care system; (ii) increase the population's access to screenings for classification according to health risk; and (iii) increase access to timely treatment for those with moderate or high health risk suffering from chronic conditions.
